



Notice to Holders of Trinidad Cooperative Bank Ltd. (TCB) Share Certificates

Holders of TCB share certificates are notified that the Central Bank of Trinidad and Tobago will be issuing payment on share Certificates commencing from **January 11th 2010 to February 26th 2010** at its offices located at Eric Williams Plaza, Independence Square, Port of Spain.

Please read the following instructions carefully.

1. Processing of payments will be done based on the listing of surnames in alphabetical order in the Table hereunder.
2. You are asked to attend at the Bank on the day listed in accordance with your surname.
3. The Central Bank will redeem certificates from Mondays to Fridays from **8:00 a.m. to 12:00 noon and from 1:00 p.m. to 2:30 p.m.**
4. Shareholders are asked to bring the following documents:
 - Share Certificates are to be produced for payment.
 - A Statutory Declaration will be required in the event Share Certificates cannot be located. Statutory Declaration forms are available from the Central Bank. The Statutory Declaration has to be sworn before a Commissioner of Affidavits, at the shareholder's cost.
 - Two (2) valid forms of identification must be presented. **One must be a picture ID.** Copies of these IDs must be provided.
 - Persons representing shareholders who are absent or who have died must present originals of either a duly executed Power of Attorney, Letters of Administration or a Grant of Probate, as the case may be. Copies of these documents must be provided for retention by the Bank.
5. A Release and Discharge form must be signed prior to payment.
6. Payments under \$2,000 will be made in cash and payments over \$2,000 will be done by cheque.
