The Central Bank of Trinidad and Tobago in partnership with De La Rue of the United Kingdom

is pleased to offer the award of three (3) Post Graduate Scholarships for the 2014/2015 academic year under the prestigious DE LA RUE SCHOLARSHIP Programme. One Scholarship will be offered in each of the following disciplines: Economics, Finance and Actuarial Science.

The Central Bank of Trinidad and Tobago and De La Rue's partnership in the promotion of these Scholarships is a strategic alliance focused on the development of our human resources in areas which are intrinsic to the development of our national economy.

Under the terms and conditions of the agreement, three (3) Post Graduate Scholarships are offered and tenable for a maximum period of two (2) academic years. Each Scholarship award is equivalent to US\$8,500.00 and will primarily cover the cost of books, materials and tuition with the balance being devoted to subsistence.

To be eligible for the scholarship, applicants must meet the following criteria:-

- (i) Be a national of Trinidad and Tobago;
- (ii) Be pursuing full-time post graduate study in the field of Economics, Statistics, Development Statistics, Business Administration or Management Studies with specialisation in Finance or Accounting (M.Sc., M.Phil./PhD) at the University of the West Indies, St. Augustine.
- (iii) Be pursuing full-time undergraduate study in the field of Actuarial Science (students entering final year in September 2015) at the University of the West Indies, St. Augustine.

- (iv) Be pursuing part-time graduate study (MBA or DBA, specialising in Finance) at the Arthur Lok Jack Graduate School of Business.
- (v) Have maintained an outstanding academic record: at least Upper Second Class Honours or equivalent and with at least a B+ average in course work for MBA, M.Sc., MPhil/Ph.D, DBA candidates.
- (vi) Be actively involved in community service.

Applicants are advised to note that the selection process will include the following:

- The completion of a 3-5 page essay on their suitability for the award of the Scholarship.
 - A selection interview conducted by a panel comprising representatives from the Central Bank and the University of the West Indies, St. Augustine.
- An assessment of the applicant's need for financial assistance. Priority will be given to those applicants who demonstrate critical financial need.

Following the completion of the programme of studies, successful candidates will be required to participate in a two (2) month internship at the Central Bank or at a designated public sector institution agreed to by the Central Bank of Trinidad and Tobago.
